- Any required permits, visas, documentation, insurance etc


Our workshops are fully inclusive and welcome people from all walks of life! We expect all our attendees to have the same mindset and be respectful to all vendors, attendees and local people.

Terms and Conditions for Shutter & Joy x Nova Wedding Co Styled Wedding Shoot - Puglia, Italy

1. Overview

These Terms and Conditions ("Agreement") apply to all participants ("Clients") attending the two-day styled wedding shoot ("Event") hosted by Nova Wedding Planning Co and Shutter & Joy (together the "Company") in Puglia, Italy.

By purchasing a ticket or attending the Event, the Client agrees to be bound by this Agreement.

2. Event Details

Dates: 8th & 9th June 2026

Location: Puglia, Italy (specific venues TBC)

Structure:

Day 1: Classic styled wedding shoot

Day 2: Wedding-themed pool party shoot

3. Styled Shoot Conditions

All styled elements (e.g., florals, wardrobe, decor) are subject to creative direction by the Company and may vary from any promotional material or brochure.

No specific setup, scene, model, or design detail is guaranteed.

The Company reserves the right to adjust or change the styling at any time, including during the Event.

A rainy day contingency plan is in place. In case of inclement weather, alternative covered or indoor setups will be used. No refunds or credits will be issued due to weather-related changes.

4. Travel and Accommodation

Clients are responsible for arranging and covering all travel, accommodation, insurance, and personal expenses related to attending the Event.

The Company assumes no responsibility for travel disruptions, cancellations, or delays.

5. Payment Terms

Full payment is required in advance to secure attendance.

No admittance will be granted without full payment.

All sales are final. No refunds will be issued under any circumstances, including non-attendance, travel issues, or dissatisfaction with creative direction.

6. Usage Rights

Clients may use all images captured during the Event for personal portfolio use, business websites, social media, and marketing materials.

All social media and online posts must credit and tag:

@shutterandjoyworkshops and @novaweddingco and all participating vendors and collaborators as provided in the vendor list by the Company.

Redistribution or sale of the images (e.g., for stock photography) is not permitted without prior written consent.

7. Model Release

All models participating in the Event will have signed a model release permitting photography and videography by all attending Clients. This release includes:

Permission to capture and publish their image in both digital and print format.

Permission for use in commercial portfolios, social media, blogs, websites, and other promotional materials by Clients.

Clients agree not to use images in any context that is defamatory, pornographic, or otherwise unlawful.

8. Code of Conduct

Clients must act professionally and respectfully toward models, vendors, fellow creatives, and the property.

No direct solicitation of models for future work outside the Event is allowed.

The Company reserves the right to remove any Client from the Event without refund if behavior is deemed inappropriate or disruptive.

9. Limitation of Liability

The Company is not liable for any personal injury, property damage, loss, or theft incurred during the Event.

Clients participate at their own risk.

The Company is not liable for travel disruptions, weather changes, or venue-related issues.

10. Media Release

The Company reserves the right to photograph and film behind-the-scenes content during the Event. By attending, Clients grant permission for their image to be used in all vendors' promotional materials, social media, website, or future advertising campaigns.
